ORDER

Various political parties are submitting the advertisements on behalf of their party, to be placed in print and electronic media, for the ensuing Municipal Elections. The Model Code of Conduct for the guidance for political parties and candidates issued by the State Election Commission is reiterated as under:-

Every political party/contesting candidate or any other person, shall seek prior certification from the Sub-Divisional Magistrate/ACP of the area concerned atleast three days prior to the proposed exhibition of the advertisement on TV Channel or on cable network or on any Radio Station by making an application. No such advertisement shall be relayed on a Radio Station or on TV Channel or published in any newspaper during the period 48 hours earlier to the end of poll.

The Hon'ble State Election Commissioner has directed that a SDM of your district may be designated to examine the proposals being received and consider permission for exhibition of such advertisements. This job has been assigned to the New Delhi district to deal with these matters as a 'Single Window System', for all the 272 wards of the three Municipal Corporations.

The Single Window System headed by SDM of your district will incorporate ACP (By name), one staff of DIP and Dy. Secretary (Home).

Therefore, you are directed to intimate name of the designated SDM with his office address and Telephone/Mobile No. by 6 p.m. today to enable its notification for benefit of all Political Parties approaching the "Commission".

Action taken to constitute the "Single Window System" with names & Details of other three members be intimated to the "Commission" by **11.00 am of 25.03.2017** without fail.

This issues with the approval of the State Election Commissioner.


