Rules, 1975, I, Rakesh Mehta, State Election Commissioner of the National Capital Territory of Delhi, hereby direct that the electoral rolls of such Assembly Constituencies, for the time being in force, as relate to the above-mentioned wards of the Municipal Corporations of Delhi, shown against each, shall be the electoral rolls for said Municipal Wards, for the purposes of the ensuing bye-elections to the said Wards of the Municipal Corporations as indicated above, to be held on 5<sup>th</sup> May, 2013.
