- 2. Team will get the help of two Beldar and two Paryavaran Sahayaks to complete the duty assigned to them.
- The vehicle of the concerned Ex. Engg. /A.E will be used for the removal of Hording, Banners displayed unauthorizedly at various places in the ward without prior payment of charges or approval of MCD.
- 4. Any complaint of any number of Hording or Banners displayed beyond the permissible numbers and locations will be removed by the team.
- All complaints received at the EDMC Head Quarter or Zonal office will be forwarded to the respective team and it will be responsibility of the each team to dispose of it within 48 hours.

- 6. Action Taken by team be informed to respective observer. Returning Officer and State Commission as well as complainant on daily basis.
- 7. The enforcement team of the zone will move around the ward on daily basis to see that there is no violation of Modal Code of Conduct. Where ever such violation is noticed and they will take so motto action immediately.
- 8. Since the Zonal area constitute very small lanes and by lanes therefore if needed other sanitation staff may be used for removal of poster, banners in the narrow lanes under the overall supervision of SS-II.
- 9. A copy of the Modal Code of Conduct and instructions (to be circulated in due course of time) to be use during the General Election to MCD, 2017.
- 10. Delhi Prevention and Defacement of Property Act, 2007 will also has to be implemented strictly.


