**IDENTIFICATION OF VOTERS**

**General Elections to 272 Wards of three Municipal Corporation of Delhi – to be held on 23.04.2017**

All electors to whom Elector's Photo Identity Card (EPIC) have been issued, shall have to produce these to cast their vote at the polling station for the General Elections to 272 Wards of the Three Municipal Corporation of Delhi to be held on **23.04.2017**. However, the electors to whom such EPIC have not been issued or whose EPIC have been lost/misplaced will be allowed to cast vote on production of any one of the following documents:-


- i) Aadhar Card.
- ii) Passport
- iii) Driving License
- iv) Income Tax Identity (PAN) Card
- v) Service Identity Card issued to its employees by State/Central Govt., Public Sector Undertakings, Local Bodies or Public Limited Companies with photograph.
- vi) Passbooks issued by scheduled Public Sector Banks/Post Office and Kisan Passbooks with photograph.
- vii) Property documents such as Pattas, Registered Deeds etc. with photograph.
- viii) SC/ST/OBC Certificate issued by the competent authority with photograph.
- ix) Pension document such as Ex-serviceman's Pension Book/Pension Payment Order/Ex-serviceman's Widow/Dependent Certificates, Old Age Pension Order, Widow Pension Order with photograph.
- x) Freedom Fighter Identity Card with photograph.
- xi) Arms License.
- xii) Certificate of Physically Handicapped with Photograph issued by the competent authority.
- xiii) Job Card issued under MNREGA with photograph.
- xiv) Health Insurance Scheme Smart Cards with photograph (issued by the Ministry of Labour).
- xv) Smart Card issued by RGI under NPR.

Any of the above mentioned documents that is available only to the head of the family may be used for identifying the other members of the family provided all members come together and are identified by the head of the family.

As per clause 2 (m) of Public Distribution System (Control) Order, 2001, Ration Card shall not be admitted as document of Identity.

All voters for General Election to the above 272 Wards are, therefore, advised to carry with them the Elector's Photo Identity Card, or any of the above mentioned documents while going to cast their vote on 23.04.2017.

Public Cooperation is solicited to ensure free, fair and peaceful poll.
