PUBLIC NOTICE

Sub: - Bye-elections to 12 Wards of the Municipal Corporation of Delhi – draft publication of list of polling stations.

It is notified for the information of general public and political parties that Bye-Elections to 12 wards of the Municipal Corporation of Delhi to fill casual vacancies of councilors shall be held in the near future.

For the purpose of the said bye-elections, the Commission has adopted the electoral rolls of such Assembly Constituencies relating to the said 12 wards and finally published in January, 2025 with the qualifying date as "1.1.2025" and as these are in force for the time being, in pursuance of the powers conferred upon the Commission under the proviso to section 7E of the Delhi Municipal Corporation Act, 1957 as amended till date read with Rule 27 of the Delhi Municipal Corporation (Preparation of Electoral Rolls) Rules, 1975.

In pursuance of provisions of Rule 10 of Delhi Municipal Corporation (Election of Councillors) Rules, 2012, the Returning Officers of the said 12 wards mentioned in the table below have prepared draft lists of polling stations showing polling areas, voters assigned and the buildings in which the polling stations will be set up.

The said draft lists are now published for inviting objections/suggestions, if any, by the public and other stakeholders, w.e.f. **9th October, 2025 upto 11th October 2025 till 03:00 P.M.** in the respective offices of the concerned Returning Officers, for inspection by public etc. during office hours on all working days.

Objections/suggestion etc. can be filed upto **11th October-2025 till 03:00 P.M.** with the Returning Officers whose designations and office addresses are given in the Table below:-
