#### CHAPTER - 1

#### **SCOPE OF WORK**

Rate contract for providing tentage services and supply of furniture, electric items, goods, tin shed barricading to set up strong rooms, counting centers, training centers etc at different places within NCT of Delhi for the general elections to the three Municipal Corporations of Delhi likely to be held in April - 2017

#### **INSTRUCTIONS TO BIDDERS**

#### Read carefully before applying for e-Tendering

#### 1. General

- 1.1 Bids are invited in two bid system i.e. Technical bid and Financial bid, from the firms having proven experience/capabilities of election related work <u>OR</u> other similar nature work done in the past in Central/State Govt. or PSU/autonomous bodies/offices/deptt.
- 1.2 Bidders are advised to study the document thoroughly. Submission of technical bids and financial bids shall be deemed to have been done after careful study and examination of the technical bids and financial bids document with full understanding of its implications.
- 1.3 It will be imperative on each bidder to fully acquaint with all the local conditions and factors, which would have any effect on the performance of the contract. No request for the change of charges or time schedule of providing of material shall be entertained on account of any local condition or factor once the offer is accepted by the State Election Commission.
- 1.4 The State Election Commission committee reserves the right to relax any terms and conditions in the Govt. interest.
- 1.5 No conditional/optional bid shall be accepted and Bidders shall not be permitted to alter or modify their bids after expiry of last date for receipt of Bids.
- 1.6 The State Election Commission reserves Right to vary level of work at the time of placement of Supply Order/Signing of Contract.
- 1.7 The requirement for tentage services and supply of furniture, electric items, goods, tin shed barricading etc. may be for setting up of counting centers, offices of Returning Officers/District Election Officers/Commission etc. The State Election Commission reserves the right to modify the work to be allotted to the firm which includes the locations.

- 1.8 The State Election Commission reserves the right to accept any bid, and to annul the bid process and reject all bids at any time, without assigning any reason, prior to placement of supply order/signing of contract.
- 1.9. Printed terms and conditions of Bidder shall not be considered as forming part of their Bids.
- 1.10 Bidder must state categorically whether or not his offer conforms to all the tender terms and conditions.
- 1.11 Bidder must state categorically whether or not his offer conforms to the requirement given BOQ (Bill of quantity).
- 1.12 Bidder must have understood that to whom contract is assigned, to complete the work to the full satisfaction of the State Election Commission.
- 1.13 Bidder who will quote all the Items as defined in the tender will only be eligible for this tender. Any bid which have partial quote for a specific job only or supply of only few items will be rejected. No conditional/optional bid shall be accepted. Bidders shall not be permitted to alter or modify their bids after expiry of the last date for the receipt of the bid. Discount shall not be offered separately. No items shall be quoted free of cost.
- 1.14 The approved contractor(s) shall also bear the cost of labour, packing, transportation for supply of hired articles to and fro from the destination. Likewise arrangements to fetch drinking water, getting temporary electric connections sanctions from, Electricity Deptt./Company etc., shall be made by the bidder himself. Such expenditure shall be borne by the Bidder. No charges for erecting poles etc. will be paid. In no case the bidder should misuse the electrical connection installed in a govt. building.
- 1.15 The contractor shall be asked to supply any item of furniture/tentage/goods for which the e- tender is being called, at any point of time or at any place within NCT of Delhi as intimated by this Commission/Returning Officers or any officer authorized to do so.
- 1.16 Bidder is bound to comply with all the legal formalities, obligations and statutory requirements as per law of the land.
- 1.17 The bidder must have capacity/sufficient stock of all tendered items. The bidder will not be allowed to delegate/transfer/assign the contract OR any part thereof to some other party.
- 1.18 The bidder whose bid is accepted shall hereinafter be called "the supplier" which shall include his Heirs, Executors, Administrators and Assignees.
- 1.19 The decision of the State Election Commission/ authorities regarding approval of rates for different categories of items will be final. No complaint in this regard will be entertained.

- 1.20 The State Election Commission has full right to accept or reject in part or any or all the bids without assigning any reason and also to cancel the order at any time by 12 hours written notice of default sent to the supplier. Firm will have no right to claim any loss/damages etc. on cancellation of supply order.
- 1.21 The State Election Commission reserves the right of placing order for all items or some items as per requirements to one or more contractors at the approved lowest rates.
- 1.22 The State Election Commission will not be responsible for any delay in online submission of the Bids due to any reason whatsoever.
- 1.23 In case of any holiday is declared by the Government on the day of opening, the tender will be opened on the next working day at the same time but e-tender can be submitted online till date and time prescribed in bid document. The tender received after the above said scheduled date and time will not be considered. No tender by FAX will be entertained.
- 1.24 The tender will be allotted strictly by taking overall quoted rates for all the items.
- 1.25 The responsibility of the material supplied by the supplier and the safety of persons deputed by him for fixation of teenage etc. shall be solely of the supplier. The State Election Commission shall not in any way be liable /responsible for any loss/damage to the material on any account if any occurred during the whole election process. The insurance of goods/stored articles etc. will be done by the bidder at their cost.
- 1.26 The bidder with seal of the firm should sign each document attached with the bid.
- 1.27 The articles of furniture/tentage/electric item, tin barricading etc., the period for which they are required and the place of supply will be intimated by the State Election Commission/Returning officer or by any officer authorized by them. The contractor should supply the material on written order by Returning Officer, State Election Commission or by an officer authorized by them.
- 1.28 All works in course of execution or once executed in pursuance of contract shall at all times be open for inspection and supervision by Returning Officers/Asst. Returning Officers or by any officer authorized by the State Election Commission.
- 1.29 The State Election Commission has full power/authority to take into account the past performance, reputation, capabilities of execution of work before awarding the contract. The bidder has to provide documentary evidence showing details of past experience of required arrangements. In addition, they have to give documentary proof of the requisite financial turnover.
- 1.30 The Commission reserves the right to relax any of the terms and conditions in the government interest.

- 1.31 The bidder shall indemnify the Commission against all damages/charges and expenses for which the Commission may be held liable or pay on account of the negligence of the bidder or his servants or any person under his control whether in respect of accident, injury to the person or damage to property of any member of the public or any person or in executing the work or otherwise and against all damages and demands thereof.
- 1.32 Bidder should have valid electrical license issued by Labour Department, Govt. of NCT of Delhi to participate in the bid.
- 1.33 The contractor shall supply all items in good condition and carry out the work with diligence. No compensation shall be allowed for any delay caused for starting of the work on account of any circumstances.
- 1.34 The successful bidder(s) has to sign an agreement as per Performa enclosed on a non-judicial stamp paper of Rs. 100/-

#### 2. Schedule of Tender:

- 2.1 Bidder has to submit on line e-Tender only.
- 2.2 The bids through e-tendering process can be uploaded till <u>10/03/2017</u> up to 01:00 PM.
- 2.3 The Technical bids received on line will be opened on <u>10/03/2017</u> at 3.00 PM. at Conference Hall of State Election Commission, Nigam Bhawan, Kashmere Gate Delhi-6.
- 2.4 After evaluation of the Technical bids along with documents as proof and EMD in the specified shape submitted by the bidders, the short-listed Bidders will be intimated the date time and place of opening of financial bids. The decision of the committee on technical suitability of the offer shall be final and shall not be open for discussion.
- 2.5 Financial bids of the only short-listed Bidders who qualify the technical Criteria will be opened.

#### 3. Bidder Qualification:

- 3.1 The "Bidder" as used in the document shall mean the one who has signed the Bid Form. The Bidder may be either the individual/Company/firm/Proprietor having required experience in this field for which charges are quoted on the BOQ (Bill of quantity as per format Annexure-C-6) and have requisite financial turnover and job orders with Government Departments.
- 3.2 Bidder must have proven experience/capabilities of election related work <u>OR</u> other similar nature work done in the past in Government/PSU/autonomous bodies. (Attach self attested copies of supply orders as a proof). The State Election Commission, Delhi has full power/authority to take into account the past performance, reputation, suitability/capabilities of execution of work before awarding the contract.
- 3.3 Bidder must have PAN, Service Tax/VAT numbers, copies of which are required to be attached with technical bid.

- 3.4 The average annual turnover of the bidder must be Rs.3,00,00,000/- (Rupees Three Crore only) and above for the preceding three financial years.
- 3.5 Bidder should have valid electrical licenses issued by the Labour Department, Govt. of NCT of Delhi.
- 3.6 Bidder should submit balance sheet for the last three years showing average annual turnover of Rs. Three Crore, and above duly certified by a Chartered Accountant.
- 3.7 The firm must have completed one job to the tune of minimum of Rs. 3,00,00,000/- (Rupees Three Crore only) or two jobs to the tune of minimum of Rs. 1,50,00,000/- (Rupees One Crore Fifty Lakh only) each and in preceding three years with any Central/State/government Department/Autonomous/PSU.
- 3.8 The bidder must not be blacklisted by any govt. deptt/organization/autonomous body etc.
- 3.9 The individual signing the tender form or any document forming part of the tender on behalf of Proprietor/Company/firm shall be responsible to produce an authenticated copy of the resolution passed by the Company, or Power of Attorney duly executed in his favour stating that he has the authority to bind other such persons of the firm as the case may be in all matters pertaining to the tender including the arbitration clauses. If subsequently, the person so signing fails to provide the said copy of resolution passed or power of Attorney within a reasonable time, the Government, without prejudice to other civil and criminal remedies may cancel the tender and hold the signatory liable for all costs and damages. In case of registered or unregistered partnership firm, all the partners should sign the tender. In case any person signs the agreement on behalf of any limited company or firm, he will produce letter of authority/resolution passed by the company empowering him to sign the agreement on behalf of the company or firm.

#### 4. One Bid per Bidder:

Each bidder shall be submitting only one bid either by himself or as a partner in joint venture or as a member of consortium. If a bidder or if any the partners in a joint venture or any one of the members of the consortium participate in more than one bid, the bids shall be rejected.

#### 5. Bid Security (Earnest Money):

- 5.1 Bid Security (Earnest Money) amount for 7.5 Lakh in the form of Demand Draft, Fixed Deposit Receipt, from any of the nationalized, scheduled or financial banks, in the name of State Election Commissioner, New Delhi. Original documents w.r.t. Earnest money alongwith other documents must be deposited in the O/o State Election Commission, NCT of Delhi well before closing date and time.
- 5.2 The Bid Security (Earnest Money) shall be valid for a period of 6 month from the date of opening bid by the State Election Commission. No interest on any account will be payable by the Commission on this amount.

- 5.3 The Bid Security (Earnest Money)/Performance Guarantee will be forfeited in the event
- a) If a Bidder withdraws his bid during the period of bid validity; or
- b) In the case of the finally selected Bidder, if the Bidder fails:
  - to furnish Contract Performance Security in accordance with terms and conditions of tender; or
  - ii) If at any stage any of the information/ declaration is found false.
  - iii) In case of failure of the bidder/supplier to execute the Contract as per the terms and conditions and to the full satisfaction of the State Election Commission, the performance security deposited by the firms shall be forfeited.
- 5.4 Bid Security (Earnest Money) in respect of the finally selected Bidder will be discharged upon the Bidder signing the Contract and furnishing of the Contract Performance Bank Guarantee.

## 6. Period of Validity of Bids:

Bids shall **remain valid for twelve months from the date of Bid opening**. A bid valid for a shorter period may be rejected by the State Election Commission as non-responsive.

### 7. Registration with Service Tax/VAT/sales tax etc. Department:

The bidders should have their firm registered with the Service Tax/VAT/sales tax Department, and shall furnish self attested copies of the same with their Technical Bid. The bidder should also submit a self attested copy of PAN/GIR issued by income tax department.

#### 8. Bid Requirements:

- 8.1 The Bidder must quote for all items as listed in the BOQ (Bill of quantity as per format Annexure-C-6) rate quoted as zero value the bid will be rejected.
- 8.2 The Successful Bidder(s) shall be required to furnish Contract Performance Bank Guarantee amounting to Rs. 20,00,000/- (Rs. Twenty lakhs only). Contract performance Security (Security Deposit) has to be obtained from successful bidder irrespective of its registration status. The Performance Security can be furnished in the shape of Account Payee Demand Draft, FDR from any nationalized, scheduled or Financial Bank in favour of State Election Commission, Delhi.
- 8.3 Bidders must submit a list of their owners, partners, etc. and a undertaking in the shape of affidavit on stamp paper duly attested by Executive Magistrate/Notary Public to the effect that the firm is not blacklisted by any Government Department/Semi Govt. Deptt/Corporation/PSU etc.. . In case the name of bidder finds mention in the list of blacklisted firms by any Govt. Department/Semi Govt. Deptt/Corporation, said firm shall not be considered for this tender.

- 8.4 Bids received without Earnest Money will be rejected out rightly.
- 8.5 Bids received only through e-tendering will be accepted. Conditional bids, Telex/Fax bids and incomplete bids will be summarily rejected.
- 8.6 Bidder must submit proof of ownership and constitution of business.

#### 9. BID PRICES:

- 9.1 The Bidder shall indicate per day rate of each item as mentioned in the BOQ. The rates should be inclusive of freight charges, packing charges and other taxes like excise duty/sales tax/VAT/ service tax etc. The validity of these rates should be one year from the acceptance of bid as per Annexure-C-6.
- 9.2 The price should be quoted strictly in line with BOQ leaving no column blank whatsoever to avoid any ambiguity/rejection as per Annexure-C-6.
- 9.3 The bidder should ensure that all columns of the BOQ may be duly filled and no column is left blank. After opening of the price bid, no clarifications whatsoever shall be entertained by the Purchase Committee.
- 9.4 The goods asked to supply should be in good condition. The Bidder is bound to supply the item/goods at the approved rates during the validity of the rate contract. If the rates of any item are reduced due to any reason during the validity of rate contract, supplier will intimate the reduced price immediately and will also charge reduced rates instead of rates quoted in the rate contract.

#### 10. Contents of Bid:

The Bids prepared by the Bidder shall comprise of the following two components: -

- a) Technical Bid comprising of the following and to be filled on the format sheets provided in the Tender Document. This is mandatory:
- i) Documentary proof of having proven experience/ capabilities of election related work <u>OR</u> other similar nature work done in the past in Govt./PSU/Autonomous bodies.
- ii) Bidder(s)/partners(s) particulars and Undertaking of not black listing by any of the Govt./Semi Govt./Corporation etc. in the shape of affidavit duly attested by the Executive Magistrate/Notary Public
- iii) Bid Form
- iv) EMD in the shape of Demand Draft/Pay Order/Bank Guarantee/FDR in favour of State Election Commission, Delhi
- v) Self attested copy of PAN, VAT/Service Tax Number.
- vi) Copy of Balance sheet of last three years duly certified by a Chartered Accountant showing minimum average annual turnover of Rs. 3,00,00,000/- (Rs.Three Crore only).
- vii) Documentary proof in support of the firm's having completed one job to the tune of minimum of Rs. 3,00,00,000/- (Rupees Three Crore only) or two jobs to the tune of minimum of Rs. 1, 50,00,000/- (Rupees One Crore Fifty Lakh only) each in preceding three years with any Govt. Deptt.
- ix) Proof of ownership and constitution of business.

- b) i). Financial Bid in accordance with the formats provided for the BOQ (bill of quantity) as per Annexure-C-6.
- ii) The price quoted should be inclusive of all taxes.

### **CHAPTER - 2**

#### **CONDITIONS OF CONTRACT**

#### 1. Contract Performance Bank Guarantee:

- 1.1 At the time of signing the contract, the **Company shall furnish a Contract Performance Bank Guarantee amounting to Rs. 20,00,000/-**(Rs. Twenty lacs only) from a Nationalized, Scheduled or Financial Bank. The Performance Security can also be furnished in the shape of Account Payee Demand Draft, FDR from any Nationalized Scheduled or Financial Bank in an acceptable form.
- 1.2 The Contract Performance Security will be in the name of the State Election Commission, Delhi.
- 1.3 The Contract Performance Security should be valid for a period of 18(Eighteen) month beyond the date of completion of all contractual obligations and no interest shall be payable on performance security. This will be release after 30 days of the successful completion of contract period.

#### 2. Payment Schedule:

- 2.1 Payment will be made after the receipt of the items/goods against the supply order in the Election Commission's store or erecting/affixing of tentage items at the place assigned, to the satisfaction of the State Election Commission. Income tax shall be deducted at source as per rules. No advance payment shall be made under any circumstances. The supplier shall deposit the copy of challans of the supplied items to the Returning Officer/or to an authorized officer of Commission as the case may be.
- 2.2 The supplier shall submit the bills in quadruplicate after due verification and certification by the Returning Officers/or by an Officer authorized by the State Election commission as the case may be.

#### 3. PENALTY:

- (a) If the Supplier fails to provide the items/item in time than Commission will arrange the same from the local market at the risk and cost of the supplier firm. In addition to above, Rs.50,000/-per day will be charged as penalty for delay/non supply.
- (b) If any equipment is not found in good working condition, penalty of Rs.5000/-per day will be charged, in addition to procurement of alternatives from local market at the risk and cost of supplier.
- (c) The decision on of State Election Commission in (a) and (b) above shall be final.

#### 4 Termination for Default

- 4.1 The State Election Commission, Delhi may without prejudice to any other remedy for breach of Contract, by 12 hours written notice of default sent to the Supplier and upon the Supplier's failure and neglect to propose and/or execute any corrective action to cure the default, terminate this Contract in whole or in part:
  - (i) If the Supplier fails to provide the material within the time period(s) Specified in the Contract; or
  - (ii) If the Supplier fails to perform any other obligation(s) under the Contract.
- 4.2 On termination of the Contract for default, performance security deposits of the Supplier will be forfeited and action will be taken to black list the Supplier.

#### 5. Resolution of Disputes:

In the case of dispute or difference arising between the State Election Commission, Delhi and the supplier relating to any matter connected with this contract, the same shall be settled through amicable negotiations between a maximum of two (2) officers nominated by the **competent authority of** State Election Commission, Delhi and Two (2) employees nominated by the supplier, failing which, the dispute shall be submitted to arbitration in accordance with the provisions of the Arbitration and Conciliation Act, and the Arbitrator's decision shall be final & binding. The language of arbitration shall be English. The venue of the conciliation and/or arbitration proceedings shall be in NCT of Delhi.
